### OFFICE OF THE ACCOUNTANT-GENERAL PRACTICE NOTE 2 OF 2006/07

# BANK ACCOUNT DETAILS IN TERMS OF SECTION 31(1) OF THE DIVISION OF REVENUE ACT, 2006 (ACT No. 2 OF 2006)

### **PURPOSE**

1. The purpose of this practice note is to provide all transferring national officers with the bank account details of each province in terms of section 31(1) of the Division of Revenue Act, 2006 (Act No. 2 of 2006)(DORA).

### **GENERAL ARRANGEMENTS**

# Intergovernmental Cash Coordination IGCC accounts of provinces

# Step 1: Transfer from the Paymaster-General (PMG) Account of the National Department of Transport (DOT) to IGCC Account.

#### INTERIM ARRANGEMENTS FOR DELIVERY OF SOCIAL GRANTS

10. The following accounts have been opened in terms of the requirements of the Division of Revenue Act, 1 of 2005 (Section 15) and are still operational until such time as these accounts are officially closed. This interim arrangement between the National Department of Social Development and provincial treasuries will terminate when SASSA and the Department of Social Development implement the new accounts configuration in line with national requirements, and thereby render the

Provincial accounts configuration redundant. This process should be concluded no later than 1 April 2007.
